Exterior Frames Overview

Endura Products' Lifetime Exterior Door Frames, are treated with Endura's Lifetime Water Repellent Wood Preservative. This water-repellent preservative is formulated to prevent moisture from penetrating deep into the component wood fibers. This treatment provides effective protection against mold, mildew and other decaying fungi, as well as improves dimensional stability and assists in the prevention of excessive dimensional swelling, splitting, end checking, shrinking and grain raising.



Lifetime Exterior Door Frame Limited Lifetime Warranty Terms and Conditions

All Lifetime Exterior Door Frames, hereafter referred to as "products" sold by Endura Products, Inc., are subject to this Exterior Door Frame Limited Lifetime Warranty (EDF Limited Lifetime Warranty).

EDF Limited Lifetime Warranty Endura Products, Inc. warrants that its products, if properly stored, transported, used, and installed according to the enclosed Care and Finishing Instructions, will be free of defects in material and workmanship and free of rot and decay for the life of the product.

Preparation, Installation and Painting of Lifetime Exterior Door Frames

- Machining: Only the routing of mortise for hinges and locks may be done to the door jambs, mull posts and mull casing. NO OTHER CUTTING, OR TRIMMING MAY BE DONE IN ANY WAY. 23
- Storage: Store only in dry and clean areas. Wood is dimensionally influenced by moisture changes in its surrounding environment. Damp, moist, or extremely humid environments are not good for wood. ci,

- 7. Anchoring: Nail or screw the actual frame into the rough opening structure, do not use the brickmould to anchor unit to the rough opening. At least one of the fasteners and anchors for each of the hinges and lock strike locations should penetrate through the door system frame and into the framing structure to provide maximum holding strength and secure anchorage. 3
- Flashing: Install at the jambs, sill and head as required to prevent water from penetrating into the wall cavity. œ
- **Caulking:** All joints must be caulked between the rough opening and the door system frame. Fill all gaps of 1/4" or more with filler and use only recommended caulking seatants and apply in accordance with the caulking sealant manufacturer's installation instructions. đ

If Endura Products, Inc. product that is the subject of EDF Limited Lifetime Warranty fails during the warranty period for reasons covered by EDF Limited Lifetime Warranty and the purchaser submits the written servica request required under EDF Limited Lifetime Warranty, Endura Products, Inc. will:

REPLACE THE PRODUCT WITH A PRODUCT THAT IS FUNCTIONALLY AT LEAST EQUAL TO THE PRODUCT BEING REPLACED AND PROVIDE UP TO \$300 IN LABOR COSTS.

Scratching the Product: Do not drag, scrape or slide the door units. They should be lifted and carried. Any damage from mishandling of the product will void this and all future warranty claims.

- 4. Rough Opening: No more than 1" higher and no more than 1-1/2" wider than the outer dimensions of the jamb (door system frame). The rough opening should be no more than 1/8" out of plumb over the height of the opening. Floor or subfloor (subsili), the lowest horizontal structural member of the rough opening) should be capable of being leveled to within +1/16" over the width of the opening. The subsill should not slope toward the interior of the home. 4
- **Caulking Sealer:** Must be applied to the rough opening as required. Assure that air-tight seal is formed beneath the sill or threshold. LO.
- Level, Plumb and Square: Assure that the door system frame is located within the rough opening and shim so that the frame is level, plumb and square. Shim behind the hinges, lock strike of the frame and upper and lower shims on the strike side of the frame. Ó

- Field Service: It is the responsibility of the installing contractor and painter to fill all nail or screw holes, and retinish raw surfaces that result from job fitting, and the cleaning of surfaces prior to painting. ó
- Pre-Painted Surface Preparation: Thoroughly dry, make free of dust, dirt, oil, grease, wax, chalk, and other contaminants. ž
- Paint Application: Paint should be applied on product, when surface, and air temperature is between 50 and 90 degrees F. Relative humidity should be below 85%. N
- Two coats of high-quality acrylic paint must be applied to the frames, brick mould, and mulls within 30 days of installation. Apply paint in accordance with the manufacturer's instructions. .

Any tampering of the original frames, or removal and/or replacement from the original location and installation will void this warranty.

1. To obtain warranty service the purchaser must submit a written service request to Endura Products, Inc. at Endura Products, Inc. 8817 West Market Street, Colfax, NC 27235

2. The written service request must include: (1) proof of purchase, (2) a copy of EDF Limited Lifetime Warranty, and (3) a written explanation of the problem

3. Purchaser/ Prehanger, together with an Endura sales representative ("Endura Rep"), field the call for a more detailed inspection to determine the cause of the complaint.

5. The Purchaser/ Prehanger and Endura Rep determine whether the unit in question was installed and assembled according to the Limited Lifetime Warranty Terms and Conditions.

6. Once the problem has been identified as an Endura Warranty Claim, Endura will replace the product with a product that is functionally at least equal to the product being replaced and provide up to \$300 in labor costs.

Problems resulting from improper installation or improper painting procedures explained in numbers 1 through 12 on the Lifetime EDF Limited Lifetime Warranty Brochure shall be the responsibility of the Purchaser.
