### FOR THERMA-TRU FIBERGLASS ENTRY DOOR SYSTEMS 5-YEAR LIMITED WARRANTY

This warranty is separate from the written warranties that accompany Therma-Tru Corporation's Classic-Craft® fiberglass entry door systems and Fiber-Classic® fiberglass entry door systems ("Classic-Craft and/or Fiber-Classic Door System"). Therma-Tru Corporation warrants the finish stain, when it is applied by Therma-Tru ("FinishRight™ on") on Classic-Craft and Fiber-Classic Door Systems, to the original owner against defects in material and workmanship for a period of five years or as long as the original owner owns the Classic-Craft and/or Fiber-Classic Door System, whichever occurs first. The warranty period begins with the earlier to occur of the date the Classic-Craft and/or Fiber-Classic Door System is purchased or the substantial completion of the building in which the Classic-Craft and/or Fiber-Classic Door System is installed. The original owner is the private residential homeowner when the Door System is first installed, not the distributor, dealer, contractor or owner of commercial multifamily non-residence owned or non-residential units. Commercial unit owners must apply for a commercial warranty. The FinishRight stain applies to the door slab, glass lite frames and sidelites.

Provided that installation, care and maintenance has been performed in accordance with Therma-Tru's published recommendations, if defective material or workmanship becomes evident in the stained finish during the warranty period, at its option Therma-Tru will provide either a) a Therma-Tru stain kit to the Therma-Tru distributor or dealer designated by the original owner and a reasonable and prevailing labor credit for the original owner's area but not to exceed \$350 in any 12 month period during the warranty term, b) replace the affected component of the Classic-Craft and/or Fiber-Classic Door System, or c) refund the purchase price (the lesser of the original purchase price or the original catalog list price).

We do not warrant that published product and technical information regarding Therma-Tru's products is consistent with applications, building customs or building standards outside of North America. Therma-Tru customers outside of North America should contact the Therma-Tru International Sales Department for specific guidelines and questions regarding product warranty. We also exclude shipping costs, and costs for installation, or reinstallation which may be incurred due to a defective part or system covered by this warranty.
